RE: DEMAND FOR IMMEDIATE REMOVAL OF DEFAMATORY STATEMENTS

NOTICE TO CEASE AND DESIST DEFAMATORY PUBLICATIONS

You are hereby notified that your article published on your website contains false, defamatory, and damaging statements about me, Felton James Jackson III. Specifically, you have falsely claimed that I am part of a list of people planning to attend a SmartLab event. This letter serves as formal notice demanding that you immediately cease and desist from making any further defamatory statements about me and remove my name from your website.

DEFAMATORY STATEMENTS

Your article located at <https://www.dehek.com/general/money-launderer-exposed-gary-woods-shocking-smartlab-scheme-recruitment-push-in-rome/> contains false and defamatory statements about me. Specifically:

- 1. You have listed my name "Felton James Jackson III" and separately as "James Jackson" as individuals allegedly involved with or planning to attend a SmartLab event**
 - These statements are absolutely false. The truth is that SmartLab attempted to solicit an investment from me and my associates, but we immediately recognized it as a fraudulent scheme and declined to invest any money. I have never planned to attend any SmartLab event, nor have I been involved with SmartLab in any capacity beyond rejecting their solicitation.

LEGAL BASIS

These statements constitute defamation per se/per quod as they:

- Are false statements of fact presented as truth
- Were published to third parties without privilege
- Have caused or are likely to cause harm to my reputation, personal relationships, and/or professional standing
- [Were made with actual malice/negligence - depending on whether you're a public or private figure]

DAMAGES

As a direct result of your false publication, I have suffered:

- Damage to my personal and professional reputation by being falsely associated with what appears to be a fraudulent scheme
- Potential harm to my business relationships and credibility
- Distress from being publicly linked to an entity I specifically avoided due to its questionable nature

DEMANDS

You are hereby demanded to:

1. **IMMEDIATELY REMOVE** both references to my name ("Felton James Jackson III" and "James Jackson") from your website article at <https://www.dehek.com/general/money-launderer-exposed-gary-woods-shocking-smartlab-scheme-recruitment-push-in-rome/> and any reference to my alleged involvement with SmartLab
2. **CEASE AND DESIST** from making any further false statements about my involvement with SmartLab or any related events
3. **PROVIDE WRITTEN CONFIRMATION** within 24 hours of receipt of this letter that both references to my name have been removed from the specified URL and that you will refrain from any future false publications about me

NOTICE OF INTENT

Please be advised that if you fail to comply with these demands within 24 hours of receipt of this letter, I will immediately pursue all available legal remedies against both you and your website hosting provider, including but not limited to:

- Filing a lawsuit for defamation seeking monetary damages
- Seeking injunctive relief against you and the hosting provider

- Pursuing all costs and attorney's fees
- Reporting the matter to relevant authorities regarding the fraudulent SmartLab scheme
- Any other relief deemed proper by the court

PRESERVATION OF EVIDENCE


You are instructed to preserve all documents, communications, recordings, and other materials related to the publication of the defamatory statements, as they may be relevant to potential litigation.

CONCLUSION

This matter can be resolved simply by removing my name from your website within 24 hours. Your false association of my name with SmartLab is particularly damaging given that I specifically rejected their solicitation after determining it was fraudulent. I am prepared to take immediate legal action against both you and your hosting provider if this matter is not resolved promptly.
