Toni Marek: "VYB so funny - that got them back, didn't it? Let me close my music PowerPoint. We didn't even get to listen to my song. I love the part where it says, 'If you've got nothing good to say, then don't say anything at all.' That's one of my favorite lines - brings good vibes."

Megan: "Speaking of good vibes, hey guys, we're going to get back to your questions in a second, but we want to bring up something important we discussed this morning. They're going to report us - so here's their strategy, it's obvious. We want to catch everyone up on the phenomenal things we're doing. Of course, we have lovers and haters."

Toni: "I'm pulling it up now. The only reason they know about this document is because I'm sharing it live."

Megan: "Here we go. Let's talk about someone - it's really freaking hilarious. I don't know how sad you are, but I'm pretty sad for this person. They must have a lot of time on their hands. But listen, we want to talk to you about things you can do. Everyone on this call - they don't want this info online because it'll be used in court. Their only goal is to harass you and harass us."

Toni: "This Zoom call is private. If someone is live-streaming this, it violates our Terms of Service. YouTube should be taking these videos down. It's a privacy issue - your name is visible, and there may be minors present. That's another violation."

Megan: "Understand this person is not a journalist - they're a sad individual. They've had videos removed for having minors on their channel. They're provoking reactions to monetize their content - maybe \$300 a month - and that's how he makes money."

Toni: "He is defaming people. He's committing targeted abuse. Police officers in his country have lawsuits against him."

Megan: "He's breaking the law, and what you can do right now is report him. Go to NetSafe - that's New

Zealand's online safety authority - and file a report. Let them know your privacy is being violated. You can also file a New Zealand Police report. I'll drop the links in the chat."

Toni: "Here's what you're going to do: go to his channel, click 'More,' then click 'Report User.' Select 'Privacy' - because you didn't authorize your name or voice to be on the show."

Megan: "Exactly. None of you gave permission. He gatecrashed a Zoom. That's hacking. He wasn't invited. He's breaking privacy laws. And by the way, shout out to Danny de Hek - because he's actually sent over 140 people to sign up with us. So thank you, Danny."

Toni: "No publicity is bad publicity, right? But I did feel sorry for him at first. I prayed for him. I really did. But now? We're just going to pray him away. I believe God will handle him. He's not walking with God. I think he used to be Jehovah's Witness - maybe got kicked out. I don't know. Something bad must've happened."

Megan: "He spends all his time interrupting our business. That's not how a man of God behaves. He's a cyberbully. If he was in front of me - in the U.S. - this wouldn't be happening. He hides behind the internet from New Zealand."

Toni: "He makes AI versions of me, he's made videos filled with lies, and he's obsessed. He's on every Zoom since December. He's creepy. He's in love with me - in all the wrong ways."

Megan: "He even put pornography in our Zoom. He's racist. He called me the B-word, the C-word. He's said everything about me. He's crossed the line. He put minors on screen. So what we're going to do is keep reporting him."

Toni: "Exactly. Go to his pages on YouTube, Rumble - anywhere you find his content - and report him. Select 'Harassment,' 'Privacy,' or even 'Child Endangerment' if your kids were on camera. He's not a journalist - he's a cyber-nuisance."

Megan: "There's power in numbers. We've got 70,000 members. If we all report him daily, YouTube will have no choice. Do it every day. Let's get this creep put away."

Toni: "If you've ever felt harassed, report him. Let YouTube know. Let NetSafe know. Let the police know. Do it over and over again."

Megan: "We've got a brand new back office, stronger than ever, thanks to this sad little man. Romans 8:28 - all things work together for good. Even cyberbullies serve a purpose."
