### 3. INCIDENT SUMMARY

This report documents a **neurologically confirmed stroke** suffered by Mr. Shavez Ahmed Siddiqui, CEO of Liquidpay Deobank, triggered by **long-term psychological harassment**, public defamation, and **targeted digital exploitation**.

#### Ongoing Cyber Harassment Since 2023

- Mr. Danny de Hek has been **repeatedly publishing defamatory videos and social media content targeting Mr. Siddiqui since early 2023**.
- These videos falsely depict Mr. Siddiqui as a criminal and scammer, despite **no legal proceedings or charges** ever being brought against him.
- This **constant digital character assassination** has caused **progressive mental stress, social humiliation**, and ultimately led to a serious **medical breakdown**.

#### Malicious Collaboration with Bloomberg Media

- In 2024, Mr. Siddiqui was contacted by Bloomberg reporter **Alice Kantor** under the **pretext of a professional interview**.
- The interview was deceptively edited and included **criminal insinuations** without evidence.
- Despite **clear written denial of publication** by Mr. Siddiqui via WhatsApp, Bloomberg **knowingly published** the defamatory video and distributed it across platforms.
- Bloomberg's **editorial team failed to fact-check or obtain legal consent**, and allowed **Danny de Hek's defaming content** to be cross-linked, thereby amplifying the psychological trauma.

#### Exploitation During Medical Crisis

- During Mr. Siddiqui's hospitalization, **Danny de Hek spread false information**, claiming he had been arrested, which caused panic among stakeholders and further emotional suffering.
- Bloomberg made **no corrective action** and continued circulating content during this sensitive period.

- **Neurological Diagnosis:** Medical experts confirm the stroke was a direct result of prolonged psychological trauma.

- **Documented Mental Deterioration:** Mr. Siddiqui suffered from **chronic insomnia, anxiety, PTSD-like symptoms**, and emotional breakdowns throughout 2023–2025.
  - **Therapeutic Burden:** Extended medical care and therapy were required, severely impacting his leadership and public image.
  - **Ongoing Damage:** Even post-stroke, the content remains live and continues to **damage Mr. Siddiqui's mental health and public perception**.

## 7. LEGAL DEMANDS & FINAL NOTICE

**To:** Danny de Hek, Alice Kantor, and Bloomberg Media Group

You are **jointly and equally responsible** for the health crisis and reputational injury caused.

You are hereby ordered to:

1. **Immediately remove** all defamatory content across platforms, including YouTube and Bloomberg-published videos.
2. **Issue a formal public apology** from all involved parties, including Bloomberg Media, stating that the content was false, misleading, and unauthorized.
3. **Pay compensation of \$300,000 USD**, covering medical expenses, therapy, emotional distress, and loss of reputation.
4. **Terminate Alice Kantor from her role at Bloomberg** with immediate effect due to gross ethical violations, malicious reporting, and failure to act upon consent withdrawal.
5. Submit formal assurance that Bloomberg Media will abstain from any further defamatory, misleading, or unauthorized content against Mr. Siddiqui or Lquidpay Deobank.

Failure to comply within **7 working days** of this notice will result in:

- Civil and criminal legal proceedings across **India, UAE, UK, USA, and New Zealand**.
  - Global takedown orders for all defamatory content.
  - Legal petitions seeking the **revocation of Bloomberg Media Group's global media distribution licenses**, citing ethical misconduct, mental harm, and violation of international media standards.
  - Formal complaints filed with global media regulatory authorities and digital platforms to ensure suspension of Bloomberg's press privileges.


