Upfront Security Deposit

To initiate the recovery process, the Client agrees to provide a fully refundable security deposit in the amount of \$ 2298 USD. This deposit enables RecoveryFin to deploy essential resources including preliminary case analysis, document validation, legal liaison, and administrative setup.

Additionally, it covers the use of advanced cyber forensic tools, blockchain tracing, and dark web monitoring technologies—integral components in identifying fund trails, digital footprints, and potential recovery vectors.

Recovery Timeline & Service Fee

- The estimated timeline for the recovery process is five (5) to seven (7) working days, commencing from the date all necessary documentation and authorizations are duly received.
- Upon successful completion of the recovery process and confirmed transfer of the full recovered amount to the client's designated account, the client agrees to remit a service fee equivalent to fifteen percent (15%) of the total recovered funds to RecoveryFin Ltd.
- This fee is payable only after the successful receipt of the recovered amount and shall be considered the final compensation for services rendered under this agreement.

Refund Guarantee Terms

RecoveryFin is committed to delivering results and maintaining transparency throughout the recovery process. While the security deposit is designed to support the initial stages of recovery, we offer a conditional refund guarantee to reassure our clients.

A full refund of the deposit may be considered if:

- No recovery—whether partial or full—has been achieved within a reasonable time frame from the date of deposit receipt.
- The Client has remained fully cooperative, providing all requested documentation, communication, and support throughout the process.
- The recovery process has not been impacted by unforeseen factors such as external interference, misinformation, or undisclosed material facts.
- All refund considerations are handled with integrity and processed promptly upon internal review and confirmation of eligibility.

Client Responsibilities

- Provide complete and accurate details of the loss, including dates, transaction records, and correspondence.
- Remain responsive and cooperative during the recovery process.
