Hello there,

My name is Elizabeth Gibbons and I am a consumer protection advocate from Ontario, Canada. I heard that you were looking for recruitment methods and impacts of cults and organised fringe groups and I wanted to help out by adding my statement. I heard about this from A Voice Downunder YouTube channel. The form on your website wasn't working for me since I am outside of AU but I am hoping you will hear from those in other countries as well about this topic. Please include the following in your inquiry...

Impact Statement: Addressing the Harm of Coercive Religious Cults

Growing up in a coercive religious environment shaped every part of my development — emotionally, psychologically, and relationally. What was presented as a spiritual path became a blueprint for manipulation, suppression, and shame. In particular, the Roman Catholic cult-like institution I experienced enforced rigid control over identity, sexuality, and personal agency. As a bisexual individual, I internalized deep guilt and fear simply for existing as I am.

These environments are not just spiritually toxic — they are socially dangerous. Their psychological frameworks often mirror those found in other coercive systems like multi-level marketing schemes, where the illusion of support conceals intense manipulation. Many people, like me, carry the trauma from one system straight into another because the psychological conditioning is so deeply embedded.

The long-term impact has been devastating. I spent years in abusive relationships shaped by patterns of self-abandonment and codependency — patterns cultivated by early indoctrination. Recovery has taken years of therapy and conscious unlearning, and I am one of the fortunate ones with access to help.

This is not a private pain — it is a public concern. These cultic systems thrive in legal gray areas, often shielded by claims of religious freedom. But freedom should never protect abuse. We need stronger legislation to define and regulate coercive control, especially when embedded in religious or pseudoreligious organizations. We need public awareness campaigns that treat cultic abuse as a legitimate public health issue. And we need mental health support specifically designed for survivors of religious trauma.

By ignoring the systemic harm these environments cause, we risk perpetuating cycles of abuse for generations. It is time to prioritize the well-being of individuals over the unchecked power of institutions. No one should have to fight for the right to exist safely in their identity.
