As you know, on January 28, 2026, PSP Legal was appointed to represent our victim group in the case against HyperTech Group and related entities (*including Hyper Series (HyperOne, HyperCommunity, HyperCapital, HyperGlobal, HyperFund, HyperVerse, HyperNation, HyperCosmos, DaoVersal), Stable DAO, Vidilook, WAAS - We Are All Satoshi, V.A.V., V.E.N.D., HyperBC Exchange/HyperPay Wallets*).

Over the past month, **PSPLegal** have thoroughly reviewed the extensive information, evidence and claims data. **PSPLegal** has confirmed their willingness to proceed with the case.

I will share detailed communications on how we will move forward - **in the Groups**. This will include information for those who have already participated, **as well the last** opportunity for anyone who missed the initial round to join. **IMPORTANT**, all new participation will close at the end of March 2026.

Thank you for the extensive meetings and information provided in respect of the

above. We are pleased to confirm the following:

1. We have been appointed to represent a victim group in a case involving the companies mentioned above, where tens of thousands have been defrauded. We are currently in the process of reviewing the information provided and will revert to you as to the next steps.
2. We are instructed to engage with Payfast (Pty) Ltd, which has unreasonably retained membership fees of victims of fraud, who paid for assistance in the recovery of their funds. We will seek the prompt release of those funds and have commenced appropriate legal action.

Miss Priya Patel will be the lead lawyer on both matters, supported by an experienced team. She is a qualified UK lawyer with over 23 years' experience, who practices in the United Arab Emirates and the UK. She has extensive experience in crypto, fintech and finance. 

The lawyer will be instructed by Iclickit (Pty) Ltd on behalf of the group action. A panel of individual victims will be appointed, representing the group, who will liaise with IClickit (Pty) and the lawyer. This is to ensure legal costs can be kept low and allow the lawyer to focus on the main preparation of the case. **As you will appreciate legal costs can escalate if time is wasted with 100's of enquiries direct to the lawyer. This setup has been established to ensure cost efficiency and that required legal work needed can be fully undertaken.**

However, it is appreciated that people may have queries and questions as we move forward, therefore a streamline process will be set up so that any individual can put forward their queries to the panel and Iclickit who will then liaise with **PSPLegal**. In addition, **PSPLegal**, the established panel and Iclickit will provide updates as the case progresses.
