**INTERIM ORDER GRANTING RECEIVER'S  
MOTION TO EXCUSE COMPLIANCE WITH 11 U.S.C. § 543**

Upon review of the Receiver's Motion (1) to Excuse Compliance with 11 U.S.C. § 543 or in the Alternative (2) to Appoint a Trustee Pursuant to 11 U.S.C. § 1104 [DE# 20] (the "Motion") filed by Michael S. Budwick, in his capacity as receiver (the "Receiver") of Goliath Ventures, Inc., a Wyoming corporation and Goliath Ventures Inc., a Florida corporation f/d/b/a Gen-Z Venture Firm, Inc. (together, the "Debtors"), the Court has determined that interim relief should be granted, a hearing by video conference should be scheduled, and deadlines imposed. Therefore, the Court **ORDERS** as follows:

1. The Motion is granted on an interim basis as provided herein.

2. The Receiver is excused from compliance with 11 U.S.C. § 543(a)-(b) on an interim basis pending further Order of the Court.

3. The Court will conduct a hearing on the Motion on **April 22, 2026** at **2:30 p.m.** by video conference using the services of Zoom Video Communications, Inc.
