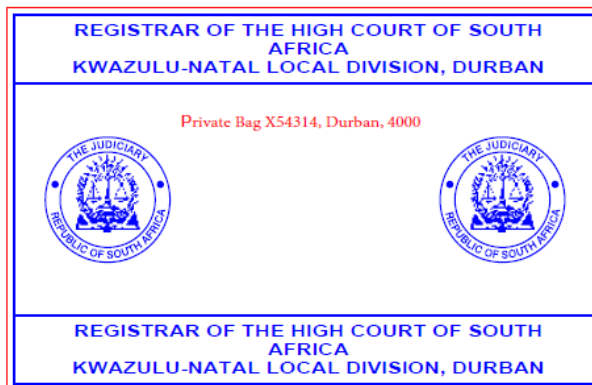

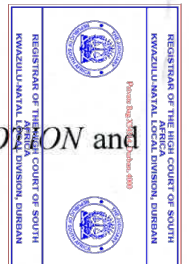

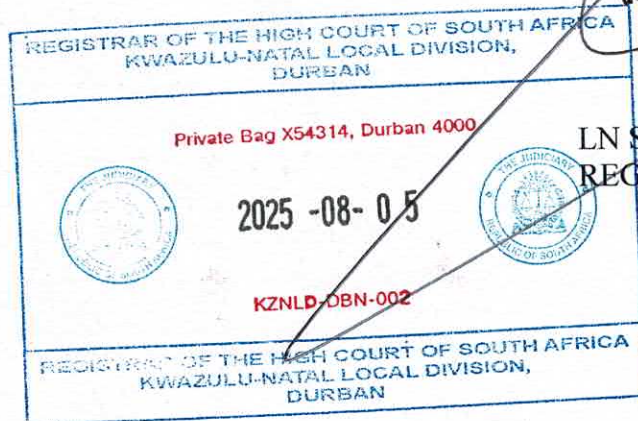
IT IS ORDERED
