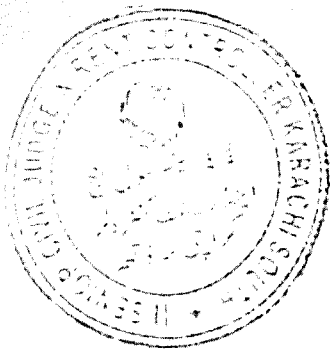
**ORDER**

12.06.2025

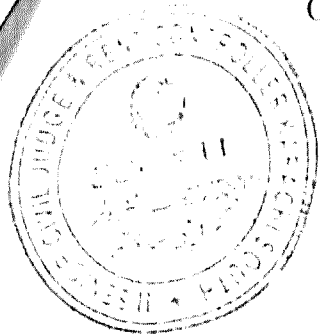
Learned counsel for the plaintiff has presented suit for Declaration, Damages and Permanent Injunction against the defendants. Learned counsel for the plaintiff also filed application U/O XXXIX Rules 1 & 2 CPC.

02. Learned counsel for the plaintiff has pressed for passing of ad-interim order on application under order XXXIX rule 1 & 2 CPC by expressing his serious apprehension that if ad-interim injunction is not granted irreparable loss/injury, hardships will be caused to the plaintiff. Learned counsel for the plaintiff contended that defendants have initiated malicious campaign against the plaintiff in order to defame the plaintiff and its officers. Learned counsel for the plaintiff further added that defendants have initiated libelous material propagated by them inter alia purports that plaintiff's directors and members are associated with a company in the name and style of EWorld Trade. Learned counsel for the plaintiff further added that defendants further claimed that EWorld Trade has been involved in distribution of synthetic opioids and other fraudulent activities. Learned counsel for the plaintiff further added that defendants' statements are false, malicious and defamatory. The plaintiff particularly underscores the fact that upon inquiring into EWorld Trade's ownership, it has learnt that its legal and beneficial ownership solely rests in one Mr. Aziz Seema, who has no ownership in the plaintiff nor do any of the plaintiff's members or directors have any stake in EWorld. Learned counsel for the plaintiff further added that acts of the defendants have besmirch the plaintiff's reputation, as such, considering the continuing actions of the defendants, the plaintiff has no other alternate, effective remedy except to file instant suit before this Court.. Lastly, learned counsel for the plaintiff, prayed for ad-interim order.

03. Therefore, at this stage, in view of the submissions of learned counsel for the plaintiff and having perused the available record coupled with averments of the plaint and its annexures, let notices be issued to defendants, meanwhile the defendants are



restrained from publishing, disseminating or distributing any defamatory statements against the plaintiff or its members directors and employees till next date of hearing. Order accordingly.
